## Hospital Physician Network Report

In March 2016, the California Department of Insurance (CDI) implemented regulation 2240.5(d)(14) of Title 10 of the California Code of Regulations. The regulation requires that every health insurer submit a hospital physician network report to CDI that provides the percentage of certain hospital-based specialists who practice at a network hospital, but are not in the insurer's network. In an effort to comply with this regulation, Health Net Life Insurance Company (Health Net) is reaching out to Health Net participating hospitals to supply this information to Health Net.

The specialties are:

- · Emergency medicine
- Anesthesiology
- Radiology
- Pathology
- Neonatology

#### REPORTING FORMAT AND SUBMISSION

Health Net is requesting that each network hospital submit information via Excel spreadsheet, by the second Friday in February and annually thereafter. To ensure clarity, providers can separate and have each specialty listed above on its own tab. Include only the specialties requested.

The report should be submitted to the hospital's Health Net provider network administrator (PNA). The PNA for your hospital will be reaching out to you shortly.

### Hospital is contracting with one group

If the hospital contracts with one group that provides any of the five services listed, the following information is needed:

- · Group name
- Tax identification number (TIN)
- The number of providers utilized from the group

### Hospital is contracting with multiple practices

If the hospital contracts with multiple practices, the following information is needed:

(\* required fields)

- Physician last name\*
- Physician first name\*
- Middle initial
- Title
