## HICN Replaced With MBI

The Medicare Access and CHIP Reauthorization Act (MACRA) of 2015, requires the Centers for Medicare & Medicaid Services (CMS) to remove Social Security numbers (SSNs) from all capitation reports by April 2019. To comply with this regulation, effective April 1, 2018, Health Net of California, Inc. (Health Net) is replacing the current Health Insurance Claim Number (HICN), which uses the member's SSN, with a random number known as the Medicare Beneficiary Identifier (MBI). The MBI is confidential and should be protected as personal identifier information. This change impacts participating physician groups (PPGs) and hospitals in the following manners:

- The MBI number is 11 characters while the HICN could range from 10 to 12 characters.
- The MBI number will occupy the record layout field position currently for HICN that exists for the capitation "Eligibility Report" (SPC\_42) and "Monthly Membership Report" (SPC\_18).
- Will require system updates to data fields to accommodate this change.

Monthly capitation reports for individual and group Medicare Advantage (MA) providers can be accessed as follows:

- Providers serving individual MA members Visit Health Net's new provider website at provider.healthnetcalifornia.com. Select product type, on the Home screen, under *Welcome*, select *Reports* > *Available Reports*.
- Providers serving group MA members Visit Health Net's provider website at provider.healthnet.com under *Provider Reports > Available Reports*.
