New IVR Self-Service Tool for Health Net Covered California and Individual Family Plan Members

- Enter both the National Provider Identifier (NPI) and tax identification number (TIN) first before entering member information.
- Include the entire numeric member ID number after the "R" or "U" as it appears on the ID card, including the two digits after the dash. Do not use MM1 or FS1.
- Include the member's date of birth (dd/mm/yyyy) and member's home ZIP code (five digits); both are required.
