# Overdose Education and Naloxone Distribution Webinar Series

In an effort to reduce negative consequences associated with opioid use, Health Net of California, Inc., Health Net Community Solutions, Inc. and Health Net Life Insurance Company (Health Net) are recommending a free two-part webinar series around the medication naloxone (brand name Narcan<sup>®</sup>) used to counter the effects of opioid overdose in a single dose.

## BACKGROUND

The California Department of Public Health (CDPH) Prescription Drug Overdose Prevention (PDOP) Initiative has partnered with the Harm Reduction Coalition (HRC) to offer the webinars, presented by Eliza Wheeler of HRC. Part one of the series will concentrate on overdose education and naloxone distribution. Part two of the series will discuss how to implement naloxone distribution systems (see attached flyer for more information).
