## DHCS Medi-Cal Documenting and Reporting Immunization Requirements

The Department of Health Care Services (DHCS) notified Health Net Community Solutions, Inc. (Health Net) on January 31, 2018, in All Plan Letter (APL) 18-004, that DHCS requires participating Medi-Cal providers to document each member's need for Advisory Committee on Immunization Practices (ACIP)-recommended immunizations as part of all regular health visits and to report the administration of immunizations within 14 days.

Preventive care service guidelines include routine pediatric immunizations recommended jointly by the American Academy of Pediatrics (AAP), the Centers for Disease Control and Prevention (CDC) ACIP and the American Academy of Family Physicians (AAFP), and routine adult immunizations recommended by ACIP that do not require prior authorization. Both the pediatric and adult immunization recommendations are available in the Health Net Provider Library located on the Health Net provider portal at provider.healthnet.com under *Operations Manuals > Benefits> Immunizations*.

Each encounter with a Health Net Medi-Cal member is an opportunity to screen immunization status and administer needed vaccines.

In addition, Medi-Cal providers are required to meet both Health Net and DHCS medical record documentation standards for preventive care as outlined in the Provider Library under *Operations Manuals > Medical Records > Medical Record Documentation > Medi-Cal Medical Record Documentation Standards*, which is revised to include documenting each member's need for ACIP-recommended immunizations as part of all regular health visits and to report the administration of immunizations within 14 days.

Providers must enroll in and use the California Immunization Registry (CAIR) website at CAIRweb.org to report and track patient immunization records online.
