## Delayed Implementation of Payment Integrity Policies

On April 16, 2018, Health Net Community Solutions, Inc. (Health Net), on behalf of CalViva Health, advised providers via provider update 18-184, *Implementation of New Payment Integrity Policies*, of the planned implementation of four new claims payment integrity policies affecting the Medi-Cal line of business. Such policies were to be effective as of June 19, 2018.

Health Net and CalViva Health remain committed to delivering affordable, high quality, patient-centered care and working together with the provider network to address rising health care costs in a meaningful way. Implementation of three of the four policies will be delayed until August 1, 2018, in order to perform additional research and analysis. The effective date of policy CC.PP.054, Physician's Consultation Services, remains June 19, 2018, as previously communicated, for the Medi-Cal line of business. Refer to the table below for revised effective dates.
