Capitation Report Changes

Effective September 1, 2018, in order to comply with Centers for Medicare & Medicaid Services (CMS) updates, Health Net of California, Inc. (Health Net) will be adding new fields to the Health Net Medicare Remittance Report (BRM 20), Activity Report (BRM 30) and Eligibility Report (BRM 42), which are distributed to participating physician groups (PPGs). The following new fields will be added to the reports:

- Adjustment reason codes (ARC)
- · CMS identification (CMS ID)
- · Medicare beneficiary identifier (MBI)
- Person ID
- Plan benefit package (PBP)
- · Risk adjustment factor (RAF)

Monthly capitation reports are available on the Health Net provider website at provider.healthnet.com under *Provider Reports > Available Reports > Capitation*. Providers can also access and view file layouts under *Provider Reports > Data File Record Layouts > Seniority Plus*.

FIELD ENHANCEMENT

The following enhancements will be added to each report:

- 1 Remittance Report (BRM 20): This report will include a field for Person ID, MBI, PBP, CMS ID, RAF, and ARC.
- 2 Activity Report (BRM 30): The member's Health Insurance Claim (HIC) code will be replaced with MBI code. The report will include a field for Person ID and ARC.
- 3 **Eligibility Report (BRM 42)**: The member's HIC code will be replaced with MBI code. The report will include a field for CMS ID, PBP and RAF.
