# Eligibility Report Field Addition for Medi-Cal Members

Effective October 1, 2018, Health Net of California, Inc. and Health Net Community Solutions, Inc. (Health Net) are adding a field to the end of the Eligibility Report (ACE 42) distributed to capitated participating physician groups (PPGs) and hospitals.

The new field, Provider Assignment Type, is for Medi-Cal members only and will be populated with one of the following indicators:

- C Member assigned to their provider choice.
- PT Member assigned due to provider transfer.
- DF Member defaulted to same provider as family member.
- DP Member defaulted to their prior provider.
- D Member defaulted to provider.

Monthly capitation reports are available on the Health Net provider website at provider.healthnet.com under *Provider Reports > Available Reports*. Providers can also access and view file layouts under *Provider Reports > Data File Record Layouts*.
