W-9 Required for Proposition 56 Supplemental Payments

All capitated Health Net Community Solutions, Inc. (Health Net) Medi-Cal providers are required to submit a current W-9 form to Health Net for Proposition 56 (Prop 56) supplemental payments. The W-9 must list all providers included under the taxpayer identification number (TIN).

The 837 files received through Health Net's encounter system cannot capture the TIN or legal entity for delegated providers. Accordingly, a W-9 must be submitted to Health Net from each provider who is eligible to receive a Prop 56 payment.

A W-9 form is included with this communication. It can also be downloaded from the Internal Revenue Service (IRS) website at www.irs.gov/pub/irs-pdf/fw9.pdf with complete instructions.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

• Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding,
