Meningococcal Serogroup B Vaccine Inventory Information Needed

Take a quick five-minute query to help identify available inventory of MenB vaccine in San Diego County

San Diego State University (SDSU) is currently experiencing an outbreak of meningococcal serogroup B (MenB) among undergraduate students ages 23 and younger.

The County of San Diego, Health and Human Services Agency (HHSA), Department of Public Health Services (PHS) is requesting information from providers on current MenB vaccine inventory available in San Diego County. This will help for better planning, anticipating and facilitating response activities as needed for the MenB outbreak.

- Combine all facility data for your organization as one inventory submission.
- If you cannot report data for your entire organization, complete separate inventory submissions for each facility.
- Include only information for facilities within San Diego County.
- Data provided must be based on point-in-time counts when the online query is completed

During the next month, PHS may request inventory information again for second dose vaccination efforts.
