## Submit a W-9 Form to Receive Prop 56 Supplemental Payments

*Email or fax your individual W-9 today with both your TIN and NPI*

As a reminder, Health Net Community Solutions, Inc. (Health Net) requires each Medi-Cal physician to submit a W-9 in order to receive the Proposition 56 (Prop 56) supplemental payment due. The participating physician group (PPG) information is not needed. The W-9 must include the individual physician's:

- Taxpayer identification number (TIN).
- National Provider Identifier (NPI) – add to the form where space is available or submit on a separate page with the W-9 form.

Monies are available and payments will be processed as quickly as possible after receiving the requested information.

A W-9 form is included with this communication. It can also be downloaded from the Internal Revenue Service (IRS) website at [www.irs.gov/pub/irs-pdf/fw9.pdf](http://www.irs.gov/pub/irs-pdf/fw9.pdf) with complete instructions.
