# Updates to Family Planning

Changes in contraceptive quantities for Medi-Cal members

On November 21, 2018, the California Department of Health Care Services (DHCS) released All Plan Letter (APL) 18-019 to clarify coverage of self-administered hormonal contraceptive supplies for family planning.

Health Net<sup>\*</sup> has updated the following quantity requirements for Medi-Cal members for the following HCPCS codes:

- S4993 up to 18 (previously 13) cycles are covered.
- J7303 up to 13 (previously 12) vaginal rings.
- J7304 up to 52 (previously 36) patches.

The maximum quantity is intended for members on a continuous cycle. A 12-month supply of the same contraceptive product may be dispensed twice in one year.

A prior authorization is required for a third supply of up to 12 months for the same product requested within a year.

When furnished by a pharmacist, self-administered hormonal contraceptives must be dispensed in accordance with a protocol approved by the California State Board of Pharmacy and the Medical Board of California.
