# Fax Your PNIP Forms by July 12 to Get \$50 Incentive Payment

## Forms received after July 12, 2019, will not be processed

The Perinatal Notification Incentive Program (PNIP) ends on June 30, 2019. All Timely Prenatal Visit and Pregnancy Notification Forms and Postpartum Care Notification Forms must be received by Friday, July 12, 2019. Forms received after July 12, 2019, will not be processed.

To qualify for the \$50 incentive payment, fax completed PNIP forms for all prenatal and postpartum services performed through June 30, 2019.

- Fax to 1-877-783-0287.
- A fax cover sheet must be added and labeled "PROTECTED HEALTH INFORMATION."

**Note**: If you get PNIP supplemental payments, you are not paid for the same measure under the primary care physician (PCP) Healthcare Effectiveness Data and Information Set (HEDIS®) Improvement Program. That would create a duplicate payment.
