# Contact the Right Source to Get Enteral Nutrition for Your Patient

## Enteral products are covered for Medi-Cal members over age 21 when diagnoses support its use

Enteral nutrition products and supplies require prior authorization. Use the table below to send prior authorization requests to the right contact. Medical chart notes must be included for medical necessity review.

Provider type	Directions to submit prior authorization
Contracting with a participating physician group (PPG)	<ul><li>Contact your PPG.</li><li>Follow the PPG's prior authorization process.</li><li>Use the PPG's forms.</li></ul>
Fee-for-service (FFS)	Download a Request for Prior Authorization form from the Provider Library at provider.healthnet.com under Forms.

## Requests are reviewed based on standard time frames

Requests for enteral nutrition products are reviewed based on the member's medical condition. When all related information is received, decisions are made in a timely manner.

Request type	Time frame
Emergency	Immediate need – prior authorization is not required when a true emergency requires immediate treatment.
Urgent	72 hours
Non-emergent/routine	5 business days

If a decision is delayed beyond these time periods, the request for authorization is approved.

## Reminder – Member benefits under age 21

Enteral nutrition products for members under age 21 may be covered by Health Net under the Early and Periodic Screening, Diagnosis and Treatment (EPSDT) program. However, if the member has a medical condition that qualifies for coverage under the California Children's Services (CCS) program, then CCS approval should be obtained for medically necessary enteral nutrition.
