The following cardio-protective medication bundle can prevent cardiovascular events.

- Angiotensin-converting enzyme (ACE)-inhibitors
- Statins
- Aspirin

Unless contraindicated, prescribe this bundle to patients who fit all of these requirements:

- Have suffered a heart attack or stroke.
- Are at high risk for a heart attack and/or stroke.
- Have diabetes and are age 55 or over (and thereby more than twice as likely to have a cardiovascular event).

Aspirin may be used in the bundle according to the individual's risk factors at the physician's discretion if no contraindication.

Success of SHAPE project

The Stroke and Heart Attack Prevention Every Day (SHAPE) project incorporates the cardio-protective medication bundle into the bigger goal of improving your patients' health and wellness. This is done through:

- The use of health care coaches, such as diabetes educators, nutritionists, dieticians, etc.
- With follow-up visits to members by telephone.
- A dedicated pharmacy program where pharmacists and technicians try to close any medication related gaps through telephonic outreach.
- Providing lists of your patients potentially eligible for the cardio-protective bundle based on their cardiac event history and pharmacy utilization.

SHAPE findings in March 2018	SHAPE success to date
 67% of Health Net's members with diabetes were not getting the cardio-protective medication bundle. Over two-thirds of all diabetes-related coronary events fell under the class of stroke and/or coronary artery disease 	 The medication adherence rate to the cardio-protective bundle has increased by 43% for those members with diabetes that were not receiving the suggested cardio-protective medication bundle at the start of the SHAPE program. Increased attention to the cardio-protective medication bundle. Increased patient engagement. Decreased emergency room use rates around cardiovascular events. Decreased per member per month (PMPM) costs through savings.

What's next?

We reviewed the project to see if there was a racial or language disparity in medication adherence rates. Based on our findings, we are developing a program in Los Angeles County to serve Chinese and Korean speaking populations.

We are currently evaluating how we can better connect with members through new technology.

We also want to find other ways to bring new information to providers. This may include events, such as dinner conferences and webinars that offer continuing medical education (CME) credit.
