

Earn an Extra Bonus with the 2020 CalViva Health Physician Incentive

The CalViva Health Physician Incentive is in addition to Health Net's 2020 HEDIS® Incentive Program

CalViva Health will provide a comprehensive quality award to multiple qualifying primary care physicians (PCPs) based on providers' sustained and improving performance across both access and quality performance measures.

Award distribution

The total award budget for 2020 is \$1,200,000.

The distribution of the budget for PCPs, Federally Qualified Health Centers (FQHCs) and Rural Health Clinics (RHCs) is based on the relative number of PCPs in each cohort.

The cohort comprises 30% PCPs and 70% FQHCs/RHCs.

- 30% of \$1,200,000 = \$360,000 (PCP allocation).
- 70% of \$1,200,000 = \$840,000 (FQHC/RHC allocation).

The number of awards for PCPs is based on membership of each county (80% Fresno, 10% Kings and 10% Madera).

Each of the top 10 PCPs will receive 1/10th (\$36,000) of the PCP allocation. Each of the top six FQHCs/RHCs will receive 1/6th (\$140,000) of the FQHC/RHC allocation.

How are you scored?

Scoring is produced at the physician site levels for both individual physicians and clinics (where appropriate and as permitted by regulation). The member minimum threshold is 500, and each PCP is eligible to earn one award.

Awards for reporting year (RY) 2020 will factor in outcomes based on both pediatric and adult outcomes and access-to-care indicators.

The plan will compare Healthcare Effectiveness Data and Information Set (HEDIS) outcomes to the National Committee for Quality Assurance (NCQA) Quality Compass percentiles, and will leverage all administrative and supplemental data supplied by providers.

Excluded providers are those who do not meet timely access standards, membership thresholds or are under a corrective action plan (CAP) for non-compliance with state or federal regulations or standards.

2020 quality measures for FQHCs and RHCs

Awards for FQHCs and RHCs will be based on year-over-year performance improvement.

For the RY 2020, awards will be based on the Managed Care Accountability Set (MCAS) as defined by the Department of Health Care Services (DHCS).
