ConferMED eConsults offers primary care providers (PCPs) secure, no-cost access to California-licensed, board-certified specialists—right from your electronic medical record (EMR) system.

Earn \$70 per eConsult

From **October 1, 2025, through October 1, 2026**, participating PCPs will receive a **\$70 incentive** for each eConsult submitted and billed within each quarter. Payments will be issued quarterly via check or electronic funds transfer to the Medi-Cal provider. This supports timely access to care and helps meet access standards.

How it works

- 
1 PCP submits eConsult: Send a digital referral with clinical information, labs and images through EMR.
- 
2 Specialist reviews: Receives and responds with treatment guidance.
- 
3 Receive response: PCP gets feedback within **3 business days**.

What is an eConsult?

An eConsult is a secure, asynchronous digital consultation between a PCP and a specialist for non-urgent, non-procedural care.

- 75–80% of eConsults prevent unnecessary in-person specialist visits.
- PCPs stay at the center of care coordination.
- Reduces duplicative testing and unnecessary referrals.

Eligibility and participation

- **Participation is voluntary.**

- **Open to fee-for-service (FFS) PCPs serving primary-insured members.** (Note, members eligible for Medi-Cal and Medicare, or Duals members, are excluded.)
- **There are no fees, software, hardware or subscription costs to participate.** ConferMED customizes the referral process to your EMR.
- **ConferMED submits claim to Health Net*, on behalf of CalViva Health, for payment of eConsult.**
- **Agree to outcome data reporting with ConferMED.** Participating FFS participating physician groups (PPGs) must agree to report utilization and outcome data to the Plan.
- **Perform and submit eConsults.** Complete and submit eConsults for eligible primary-insured members during the pilot period: **Oct. 1, 2025, through Oct. 1, 2026.**
