
- General CalAIM information Includes provider guides, claims/invoice submission processes, and electronic data interchange (EDI) instructions available in English and other languages.

What is CalAIM?

CaIAIM (California Advancing and Innovating Medi-Cal) is a multi-year initiative by the California Department of Health Care Services (DHCS) to improve the quality of life and health outcomes of Medi-Cal members through broad delivery system, program and asyment reform across the Medi-Cal program. (Note, Community Supports (CS) program services are available for Cal MediConnect enrollees.)
