

# Interested in Joining California's COVID-19 Vaccine Network?

The California Medical Association (CMA) provides onboarding support to select providers and groups who have expressed interest in joining the network but who are not yet contracted.

## How will I be contacted?

California's third-party administrator (TPA) has provided CMA a list of pediatric providers, individual practitioners and small group practices who have inquired with the TPA about joining the network. CMA will be contacting these providers directly with more information.

## What do I need to know?
