

Help Asthma Patients Remove Triggers in Their Home at No Cost

Remediation services, or asthma trigger remediation, offers an in-home trigger assessment for members with poorly controlled asthma. Members managing asthma can learn how to remove asthma triggers from their home to ensure their health, welfare, and safety, while reducing acute asthma episodes that could result in the need for emergency services and hospitalization.



Program Services


- Home environment assessment by a certified asthma educator.
- Equipment and supplies.
- Facilitation of primary care physician or other provider well visits.
- Education about asthma controller and rescue medication use, including of metered dose inhaler (MDI) technique and usage monitoring device.
- Case management and asthma remediation team that includes certified asthma educators and respiratory therapists.
- Some examples of provisions and services include:
 - High-efficiency HVAC filters, air cleaners and air purifiers.
 - High-efficiency particulate air filtered vacuums.
 - Ventilation improvements (e.g., repair or replace range hood).
 - Evaporative cooler cleaning and maintenance.
 - Hygrometer, a humidity monitor.
 - Integrated Pest Management (IPM) services.
 - Mold removal and remediation.
 - Allergen-impermeable mattress and pillow dustcovers.
 - Asthma-friendly cleaning supplies.
 - Spacer for MDI.
 - MDI use and technique monitoring device.
 - Other repairs found to be medically needed and cost effective.



Required Documentation/Referral Source





• Evaluation - A brief written evaluation specific to the member describing how and why the remediation(s) meets the needs of the individual; required for cases of other interventions identified to be medically appropriate and cost-effective.

- Additional documentation submitted from Community Supports Provider or others.
- A home visit conducted to determine the suitability of any requested remediation(s) for the member. The home visit may occur post referral by physician or other provider.
