ConferMED eConsults offers primary care providers (PCPs) secure, no-cost access to California-licensed, board-certified specialists—right from your electronic medical record (EMR) system.

Earn \$70 per eConsult

From October 1, 2025, through October 1, 2026, participating PCPs will receive a \$70 incentive for each eConsult submitted and billed within each quarter. Payments will be issued quarterly via check or electronic funds transfer to the Medi-Cal provider. This supports timely access to care and helps meet access standards.

How it works



PCP submits eConsult: Send a digital referral with clinical information, labs and images through EMR.



Specialist reviews: Receives and responds with treatment guidance.



Receive response: PCP gets feedback within 3 business days.

What is an eConsult?

An eConsult is a secure, asynchronous digital consultation between a PCP and a specialist for non-urgent, non-procedural care.

- 75-80% of eConsults prevent unnecessary in-person specialist visits.
- PCPs stay at the center of care coordination.
- Reduces duplicative testing and unnecessary referrals.

Eligibility and participation:

- · Participation is voluntary.
- Open to PCPs serving primary-insured members.
- There are no fees, software, hardware, or subscription costs to participate. ConferMED customizes the referral process to your EMR and handles billing coordination with the Plan.
- Agree to data reporting. Participating FFS participating physician groups (PPGs) must agree to report utilization and outcome data to Health Net*, on behalf of Community Health Plan of Imperial Valley.
- Perform and submit eConsults. Complete and submit eConsults for eligible primary-insured members during the pilot period: Oct. 1, 2025, through Oct. 1, 2026.

Exclusions:

- PPGs with shared risk contracts.
- Secondary Medi-Cal coverage
