



Immunize Patients Under 2 Years of Age and Earn a \$2500 Incentive!

THE INCENTIVE BEGAN MAY 1, 2025 THROUGH THE END OF YEAR FOR MARKETPLACE/AMBETTER MEMBERS

Health Net is offering providers a \$2500 incentive for every member who completes the childhood immunization status combination 10 (CIS-10) immunization series by their 2nd birthday. This also applies to any children who may be assigned to your care in the future. Refer to the table below for the 10 recommended vaccines that should be administered to children by their 2nd birthday.*

What you need to do:

1	Review Health Net's care gap reports to identify which patient(s) may still need the CIS-10 immunizations. Contact your Health Net representative for help.
2	Contact the parents/guardians of patients ages 0-2 years. Encourage parents/guardians to complete the child's CIS-10 immunization series before the child turns 2 years of age.

How to receive incentives:

1. Submit the patient's updated immunization records to Health Net.
2. Highlight the vaccines received that close CIS-10 care gap and fax the records to:

Note: Physicians and other providers can also submit documentation if a child is excluded from the measure (e.g. due to a contraindication). Once verified, the provider can still qualify for the incentive.

Child and adolescent immunization series

The following are recommended CIS-10 vaccines for children ages 0-2 years to receive by their 2nd birthday.

Vaccines	Doses (Count)	Due Date
Diphtheria, tetanus, and acellular pertussis (DTaP)	4	On or before 2nd birthdate
Haemophilus influenzae type b (Hib)	3	On or before 2nd birthdate
Hepatitis A (HepA)	1	After 1st birthday up to 2nd birthdate
Hepatitis B (HepB)	3	On or before 2nd birthdate
Inactivated poliovirus (IPV)	3	On or before 2nd birthdate
Influenza (Flu)	2	Starting at 6 months to 2nd birthdate
Measles, mumps and rubella (MMR)	1	After 1st birthday up to 2nd birthdate
Pneumococcal conjugate vaccine (PCV)	4	On or before 2nd birthdate
Rotavirus (RV)	2 or 3	Two doses at 2 and 4 months (Rotatix) Three doses at 2, 4 and 6 months (RotaTeq) Note: Cannot be administered beyond 8 months, 0 days.
Varicella (VZV)	1	After 1st birthday up to 2nd birthdate
