Review drug list changes and medication safety issues

FDA approves first generic referencing Victoza (liraglutide injection)

On December 23, 2024, the FDA approved the first generic referencing Victoza (liraglutide injection) 18 milligram/3 milliliter. Liraglutide injection is a glucagon-like peptide-1 (GLP-1) receptor agonist indicated as an adjunct to diet and exercise to improve glycemic control in adults and pediatric patients 10 years of age and older with type 2 diabetes (T2D).

There has been a shortage of GLP-1 medications since 2023 due to high demand driven by the popularity of drugs like Ozempic®, which is approved to treat type 2 diabetes but is used off-label as a weight loss medication. The FDA prioritizes assessment of generic drug applications for drugs in shortage to help improve patient access to these medications.

According to the Office of Generic Drugs in the FDA's Center for Drug Evaluation and Research, generic drugs provide additional treatment options which are generally more affordable for patients. This approval for liraglutide injection emphasizes the FDA's continued commitment to advancing patient access to safe, effective and high-quality generic drug products.

Liraglutide mimics GLP-1, a naturally occurring hormone in the pancreas that regulates blood sugar levels by releasing insulin. The most common side effects of liraglutide injection include nausea, diarrhea, vomiting and decreased appetite. Prescribing information also includes a warning for the potential formation of thyroid C-cell tumors including medullary thyroid carcinoma (MTC). For this reason, patients with a personal or family history of MTC and patients with an endocrine system condition called multiple endocrine neoplasia syndrome type 2 should not use liraglutide.
