

# Immediate Action Required: Complete the Implicit Bias Training to Stay Compliant

**Ensure compliance and demonstrate your commitment to fostering an inclusive environment.**

The Implicit Bias Training is a requirement under California’s Dignity in Pregnancy and Childbirth Act (SB 464). This training is mandatory for all providers involved in perinatal care. It is designed to reduce disparities in maternal health outcomes through evidence-based education on unconscious bias, cultural competency and reproductive justice.

## Who should attend?

All healthcare professionals involved in perinatal care, including:

- Clinical and non-clinical medical staff
- Pediatricians
- OB/GYNs
- Physicians’ assistants
- Licensed vocational nurses
- Medical assistants
- Individuals who provide perinatal care



### Critical Deadlines

- Current health care providers involved in perinatal were to have completed their initial implicit bias training by June 1, 2025.
- New healthcare providers must complete the training within 6 months of their start date, unless exempted.
- After the initial training, providers must take refresher courses every 2 years.
- Compliance reporting – Effective February 1, 2026, facilities must submit proof of compliance annually to the California Attorney General.

### What you need to do

If you missed the June 1, 2025 deadline for completing training, you must complete the training as soon as possible. Currently, there are no indications that late completion disqualifies a provider permanently, but delays may increase risk for the facility.

- This training also focuses on increasing cultural conscientiousness, sensitivity and humility. It can help broaden participants' awareness of their own implicit biases (subtle, unconscious assumptions about others).
- It equips participants with tools to engage with members in more open, respectful and empathetic ways. Improvement in these areas can help impact quality of care and outcomes.
