

#### What is Cozeva?

In early 2020, Health Net rolled out a web-based platform to help providers stay engaged in Healthcare Effectiveness Data and Information Set (HEDIS®) performance and raise county benchmarks. The Cozeva® platform gives providers a bird's-eye view of members who need preventive care and chronic disease management services, as well as timely insights into member care transitions from emergent and inpatient settings. The system is user-friendly and provides an at-a-glance color coding system that shows providers which members are due for routine screenings or immunizations.


### Start using Cozeva now!

Start using Cozeva to identify any data gaps/discrepancies that exist with the health plan. Submit missing records as supplemental data where necessary to address those gaps by February 4, 2022.

Cozeva is available at no cost to Health Net primary care physicians and clinic providers, as well as to participating provider groups. There is no limit to the number of accounts that can be set up for a provider office.



# Cardiac + Diabetes: Health Net's Stroke and Heart Attack Prevention Initiative

Health Net's innovative population health approach, Cardiac + Diabetes, utilizes a polychronic focus to disease management for members with multiple coexisting comorbidities.

Across the nation, diabetes affects more than 30 million people and is the seventh leading cause of death. If not properly managed, it can lead to renal, vision and hearing impairment, and cardiovascular disease. If complicated with other chronic comorbid conditions like high blood pressure and coronary artery disease, care utilization is very high. This, in turn, affects the patient's quality of life and presents a challenge when navigating the health care system. Utilization is primarily around pharmacy, inpatient and emergency room costs.


### The program goals include:

- Timely intervention.
- A focus on prevention and developing wellness into the lifestyle.
- Using evidence-based strategies to incorporate best practices.

#### How:

 Outreach to high-risk members with diabetes, coronary artery disease and high blood pressure. Outreach consists of live calls, interactive voice response (IVR) calls, email, mail and cell phone text messaging. IVR calls typically have an interactive script for the member if the member answers the phone. Otherwise, the member receives a short, prerecorded and Health Insurance Portability and Accountability Act- (HIPAA-) compliant voicemail message with a number that the member can use to call back.

### RVax180: Vaccination Outreach Is Underway!

Californians can get a COVID-19 vaccination or flu shot easily, thanks to Health Net's RVax180 initiative. The initiative's goal is 180 vaccination outreach events over 12 months.

More than 110 events have already been completed since April 2021, administering more than 12,000 vaccinations. Events range from providing an RV for vaccine administration to arranging for providers to administer the vaccines.

COVID-19 clinics are based in counties with the highest rates of unvaccinated Health Net Medi-Cal members.

Health Net's new recreational vehicles, dubbed RVaxes, will be on the road across the state to provide more people with access to the COVID-19 vaccines.

Each van has three private workspaces for vaccine administration.

# **COVID-19 Vaccine Community Events with the LA Rams**

The Los Angeles Rams football team has been partnering with Health Net for a number of RVax180 events. Thirty such events involve LAUSD middle schools, where clinicians offer vaccines as part of a Rams-sponsored flag football after-school program.

### Health Net and the Rams team up at SoFi Stadium

Los Angeles' new SoFi Stadium, home to the Rams and the Chargers, was the scene of a Health Net vaccination event on September 25, 2021. The Rams, Health Net and the Los Angeles County Department of Public Health teamed up to help get more residents their first or second dose of a COVID-19 vaccine.

Any Los Angeles resident who was eligible to receive a COVID-19 vaccine was invited. In addition to getting vaccinated, recipients were entered into a drawing to win tickets to the Rams vs. Cardinals football game on October 3.

# Pro Football Hall of Famer joins a community event with Health Net

In addition to the Rams, USC Trojan and Pro Football Hall of Famer Anthony Muñoz recently teamed up with Health Net to raise awareness about COVID-19 and the benefits of vaccinations. The former USC star visited the local communities of East L.A. and Ontario at a critical time as the delta variant spread among SoCal residents.

"When I was in college, I had three knee operations, which enabled me to play 13 seasons in the NFL," Muñoz said. "If I listened to the medical professionals then, why wouldn't I listen now? I know I'm not a doctor, but I've educated myself, and this is important."

Munoz was joined by Health Net's Medi-Cal Medical Director Dr. Ramiro Zúñiga. Zúñiga was onsite to help answer any questions or concerns from residents regarding the various vaccines.
