At The Fresno Center’s Living Well Mental Health Clinic, clients are the gardeners—cultivating produce, learning strategies to manage stress and anxiety, and building confidence through hands-on experience. Licensed clinicians provide group therapy, peer support and wellness education, using the garden as a restorative setting for growth and recovery.

“Community gardens are powerful tools for improving health outcomes and building stronger neighborhoods,” said Jeffrey Nkansah, CEO of CalViva Health.

Through this collaboration, CalViva Health and The Fresno Center are transforming underutilized land into thriving spaces that nourish both the land and its people. The Healing Garden also welcomes local schools and nonprofits to participate in hands-on learning, promoting sustainability and community engagement.

California's plan to reshape Medi-Cal, known as CalAIM, presents a powerful way to build a system that truly meets the needs of its members. **Health Net is committed to helping lead this change.** We've worked to help expand the Medi-Cal framework and help ensure every member receives the right care, at the right time, in the right place.

At the [Vision y Compromiso Conference](#), Health Net announced a \$1.7 million MOVES partnership. This will expand training, mentorship and job placement for Promotoras and trusted Community Health Workers—people who bridge cultural and language gaps.

# LA Family Housing to Grow Location Program with \$2 Million Grant

Health Net awarded a \$2 million grant to [LA Family Housing](#) to grow its Housing Location Program in Service Area 2. The program helps individuals and families move from homelessness into stable, permanent homes.

# \$3 Million to Expand Behavioral Health Services in San Joaquin County

Health Net invested \$3 million to build the [SJ BeWell Campus](#) in San Joaquin County. This new center will offer crisis intervention, stable housing and long-term treatment.

The campus will be a central hub for behavioral health services. It will improve access to care for thousands of local residents in great need.

# Amber Kemp Shares Health Net's Role in Housing Solutions at Sacramento Summit

At the 11th Annual Sacramento Regional Affordable Housing Summit, Health Net's Amber Kemp, vice president of Medi-Cal strategy, execution and engagement, joined a panel on Addressing Homelessness in a Time of Change. She detailed how Health Net uses CalAIM programs and partnerships to:

- Bridge health care and housing.
- Improve stability.
- Reduce costs.

## Key points included:

- Proposition 1 – new funding for wraparound services.
- CalAIM's success in helping to lower ER visits and homelessness rates.
- Health Net's \$247 million investment in community-driven solutions since 2020.
