## Hard-to-Reach California Communities Get On-the-Spot Preventive Care and Support Through \$7.2M Mobile Clinic Investment

Health Net and the Centene Foundation will invest more than \$7.2 million to help bring mobile clinics and health care services to California communities that need them. The mobile clinics offer a means to help improve care access, quality and health outcomes.

Services include:

- Preventive care
- Social support
- Health education and more

“Mobile clinics are so important, especially in places where it’s hard to get to the doctor,” said Dorothy Seleski, President of Medi-Cal at Health Net. “These clinics provide checkups, education and support right where people live.”

The mobile clinics are part of the new [Mobile Outreach for Value, Equity and Sustainability \(MOVES\) program](#). MOVES helps people get care without losing work time or travel issues. Mobile vans visit parks, events and neighborhoods to offer care to thousands of people.

## Former Sacramento Inmates Access Shelter and Support Services Powered by Health Net’s \$2.6M Grant

People in Sacramento County who leave jail often have a hard time finding a home, job or doctor. To help, Health Net gave \$2.6 million to Hope Cooperative. The money pays for a 59-room motel where people can stay while they get back on their feet. It also helps them get:

- Doctor visits
- Mental health care
- Addiction help
- Job coaching
- Advice and help finding a home

Health Net partners locally to stop the cycle that leads people back to jail. Many people lack proper support. The Health Net grant gives them a better chance to start fresh and live healthier lives. Hope Cooperative is a CalAIM Community Supports project. It helps connect people to care and services that meet their needs.

- The \$2.6M grant supports interim housing and supplemental services for those exiting the justice system.
- Hope Cooperative operates the 59-room motel as short-term housing.

# California DHCS Issues Statement on Federal Use of Medi-Cal Data and Member Privacy

The California Department of Health Care Services (DHCS) states the following:

“...Recent reports have raised serious concerns about how federal agencies may be using Medicaid data, including the personal data of all 15 million Californians covered by Medi-Cal. We want to clarify what we know and the actions we are taking.

We are aware of reports that the federal Centers for Medicare & Medicaid Services (CMS) or the U.S. Department of Health and Human Services may have shared the personal data of Medi-Cal members with the Department of Homeland Security. Upon learning of these reports, DHCS reached out to CMS requesting information to confirm whether this occurred and exactly what data was shared, to which agencies, and why. DHCS has not received confirmation that such sharing occurred, nor do we know what data may have been involved or for what purpose. We are actively seeking answers from our federal partners.”

# California Medicare and Medicaid Members Get Expanded Options in 2026 Plans

## **More options for dual-eligible members across 41 counties**

Starting in 2026, dual-eligible members (those eligible for Medi-Cal & Medicare) will have access to Medi-Medi Plans in 29 more counties across California. Members in a total of 41 counties will have the option to choose a Medi-Medi plan. Some of the counties impacted include Amador, San Joaquin and Stanislaus, where Health Net has a strong presence. This expansion ensures more members can get coordinated care that meets their full needs.
