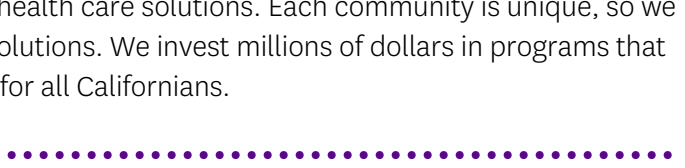

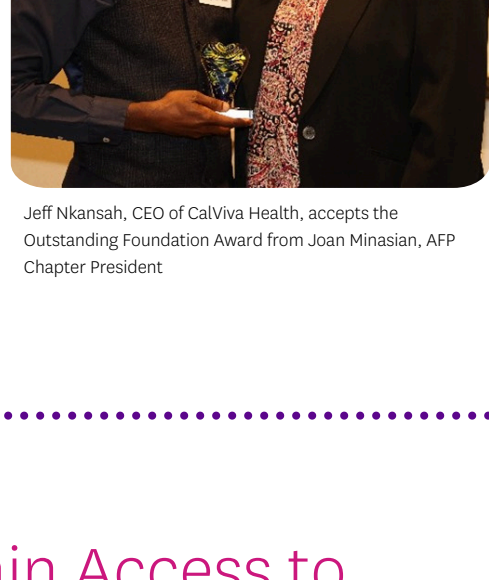

## ACCESS

### Justice-Involved Californians Gain Access to Medi-Cal Services

#### DHCS approves targeted services for three California counties

As of October 1, 2024, the California Department of Health Care Services (DHCS) approved three California counties to provide a targeted set of Medi-Cal services to people who return to neighborhoods after incarceration. Action is underway in Inyo, Santa Clara and Yuba Counties. All other counties are required to start by October 1, 2026.

The Justice-Involved Reentry Initiative includes medical and behavioral health services for Medi-Cal eligible adults and youth in:

- State prisons
- County jails
- Youth detention centers

## HEALTH EQUITY

### Physicians Seek Greater Health Equity Through Fellowship

In August, Health Net hosted the [National Hispanic Health Foundation \(NHHF\) California Leadership Fellowship](#).

The NHHF Leadership Fellowship strives to advance the careers and leadership potential among skilled Hispanic physicians. At best, the doctors will have a **stronger voice for policy making**, and be able to hold **more executive positions** at the federal, state and local levels.

The Fellowship's primary goal is to **improve the quality of health for all Americans**.

### Health Net's Leadership in Health Equity is Recognized Again

Health Net **retained** its Health Equity Accreditation Plus (HEA+) distinction from the National Committee for Quality Assurance (NCQA). We are **one of only three California health plans with an HEA+ distinction** from NCQA. Plus, out of more than 25 plans nationwide with HEA+, Health Net is the **only plan** that holds the honor across:

- Medicaid
- Medicare
- Commercial
- Exchange

NCQA's Health Equity Accreditation **awards** the **bedrock of health equity work** which includes:

- Growth of an inner culture that supports health equity work
- Data collection
- Language services
- Culturally sensitive provider networks
- Impactful ways to address disparities and social risks

The Health Equity Accreditation Plus (HEA+) program is a voluntary add-on option. It focuses on partnerships that help **ease social risks** and **address social needs**. Guidelines include:

- Data collection of:
  - Members' social needs
  - Community risks
- Partnerships with community-based organizations
- Ideas that create chances to improve the social need referral process

## GRANTS

### Sacramento Homeless Receive Help With Funding From Saint John's Real Change Program

The Sacramento-based Saint John's Program for Real Change provides housing support payments to unhoused and at-risk people, in part with about \$42,500 in funding from Health Net. The organization also hired a housing specialist who has worked with the targeted population. And they chose case management software to support housing-related Community Supports services to help scale the program.

Outreach to local housing services providers through Sacramento Steps Forward, the local continuum of care coordinator, yielded increased interest from prospective applicants.

### California Medi-Cal Providers Can Apply for New Funding Opportunity Through the PATH CITED Program

#### Providing Access and Transforming Health (PATH) Capacity and Infrastructure Transition, Expansion, and Development (CITED) Round 4 Application Opens on January 6

On January 6, 2025, the Department of Health Care Services (DHCS) will open the [PATH CITED](#) Round 4 application window.

The PATH CITED initiative provides funding to build the capacity and infrastructure of on-the-ground partners to successfully participate in Medi-Cal. They include:

- Community-based organizations (CBOs)
- Hospitals
- County agencies
- Tribes and others

The deadline to apply for PATH CITED Round 4 funding is March 7, 2025, 11:59 p.m. Pacific time.

#### Application Preview

DHCS published the PATH CITED Round 4 [application outline](#) and [funding request workbook](#) to help prospective applicants prepare the resources and information required to complete their application prior to the funding window that opened on January 6, 2025.

The application outline should be used as a planning tool; it is not the formal application. Applicants are still required to apply for PATH CITED Round 4 funding using the link that is available on the PATH CITED website.

Prospective applicants are also encouraged to review the [CITED Round 4 Guidance Document](#) before applying.

#### PATH CITED Round 4 Eligibility

Organizations eligible to apply for Round 4 funding include:

- CBOs
- County, city, or local government agencies
- Federally Qualified Health Centers
- Medi-Cal Tribal and Designee of Indian Health Program
- Providers (including but not limited to hospitals and provider organizations)
- Others as approved by DHCS

#### PATH CITED Round 4 Priorities

CITED Round 4 priorities include the following:

- Enhanced Care Management (ECM)/Community Supports (CS) in rural counties
- Statewide ECM needs
- Tribal partners and providers
- Statewide Community Supports services needs
- County-specific gaps in ECM by Population of Focus
- County-specific gaps in Community Supports services by Community Support type
- CBOs
- Counties providing Transitional Rent

### Health Net Grant for UC Davis Stem Cell Program to Improve Access to CAR T-Cell Therapy

#### Funding promotes local production of CAR T-cell immunotherapy for cancer patients

UC Davis Health's Stem Cell Program has received a \$500,000 grant from California health insurer Health Net to improve cancer patients' access to life-saving CAR T therapies and clinical trials. CAR (chimeric antigen receptor) T-cell therapy is a form of immunotherapy that reprograms the immune cells to better target diseases such as cancer.

"Our CAR T program makes this treatment affordable and accessible to patients in 33 nearby counties and people in the Bay Area. We are providing CAR T products for over half of the state!" said Professor Jan Nolta, director of the Stem Cell Program. Nolta also directs the Institute for Regenerative Cures and the UC Davis Gene Therapy Center. "This Health Net grant is an excellent step forward for our CAR T program to help more cancer patients. It provides a budget to continue our movement toward affordability and access to patient care."

#### The objectives of the new grant

The new grant will support clinical trials and the development of new and better CAR T-cell products at the Stem Cell Program's Alpha Clinic. The objective is to advance the science of CAR T therapy and improve patient outcomes.

The grant will also support therapies that may treat more patients, especially those who are underinsured and underserved. It aims to reduce costs, boost accessibility and facilitate patient participation in clinical trials. The grant will help reduce barriers to accessing treatments by assisting with travel, accommodations and lab testing in or near patients' homes.

"Health Net's mission is to transform the health of the communities we serve, one person at a time," said Dr. Todd May, vice president and medical director at Health Net. "We are proud to support the UC Davis team's pioneering and cutting-edge cancer research with this \$500,000 grant, and to support work that aims to create a more effective, accessible and affordable CAR T cancer treatment."

Dozens of other organizations that include local, county, state and federal government offices and advocates helped contribute to the effort. All were part of the team that has brought The Neighborhood Village to completion.

- Prepare food for mobile outreach to support other unhoused people in Tulare County
- Offer income prospects for TNV residents
